#### For which purposes do we process your personal data?

Organizational team: we process the personal data provided by you (name, e-mail address, preferred pronoun) for the purposes of the recruitment process for the European Youth Meeting (EYM) organizational team in 2024 (e.g. to identify and keep in touch with you related to our EYM activities). We process your country or Amnesty Section as we want to keep the geographical balance in our team.

<u>Participants</u>: we process the personal data provided by you (name, e-mail address, phone number, preferred pronoun, dietary requirements, any accessibility requirements/additional support needs) for the purposes of your participation at the EYM in 2024 (e.g. to identify and keep in touch with you related to our EYM activities). We process your country or Amnesty Section as we want to keep the geographical balance in our team. For underage participants, we process the name of the person you are travelling with and their phone number in case of emergency.

#### What is the legal basis for our data processing?

Your free consent (GDPR Article 6 (1) a)). Please be informed that the provision of your personal data is not based on a legal or contractual obligation and is not a prerequisite for entering into a contract, and that you are not obliged to provide your personal data and that there are no consequences for not providing it. There will be no transfer of data outside the European Union/European Economic Area or to an international organisation.

Who can access your personal data? Your personal data can be accessed by our colleagues at the Association, to perform their tasks. Beyond that, the Association's CRM developer (Reflexive Communications Polgári Jogi Társaság, 1039 Budapest, Ady Endre u 60., communications@reflexive.hu, its IT advisor (Lovas Gergely e.v., 1027 Budapest, Margit krt. 64/B., gergely.lovas@outlook.com), IT personnel (Kineon-IT Műszaki Szolgáltató Kft., 1138 Budapest, Népfürdő utca 37. 3. em. 9., info@xineon-it.hu) may access them as technical data processors, with whom we have concluded data processing agreements guaranteeing the security of your data. Otherwise we do not disclose your data and we do not forward them to anybody else, except for Amnesty International Sweden, Amnesty International Italy and (participants' data) for the EYM organizational team selected by Amnesty International.

For how long do we store your data? Your data will be processed until the termination of the European Youth Meeting in 2024, after which it will be deleted.

# What rights do you have regarding your personal data?

# Right to be informed /right of access

On the contact given above (office@amnesty.hu), you can ask us via e-mail whether we process your personal data or not.

If such data processing is ongoing, you may request information from us about what personal data, on what legal grounds, for what purposes, from what source and for how long did we process and also about to whom, when, based on what laws did we grant access to or forwarded which personal data of yours, including especially recipients outside of the EU and international organizations.

We will answer your request within 30 days, via e-mail sent to the e-mail address given by you. You may gain access in a way that we send you your affected personal data via e-mail.

## Right to rectification

On the contact given above (office@amnesty.hu), you can ask us via e-mail to immediately rectify your personal data you think is inaccurate. You also have the right to ask us to complete personal data you think is incomplete.

# Right to erasure / right to be forgotten

On the contact given above (office@amnesty.hu), you can ask us via e-mail to immediately erase your personal data in the following certain circumstances:

 a) the personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed;

- b) you withdraw your consent on which the processing is based, and where there is no other legal ground for the processing;
- c) you object to the processing and there are no overriding legitimate grounds for the processing,
- d) your personal data have been unlawfully processed;
- e) the personal data have to be erased for compliance with a legal obligation we are subject to;
- f) the personal data have been collected in relation to the offer of information society services for children.

#### Your right to restriction of processing

On the contact given above (office@amnesty.hu), you can ask us via e-mail you can ask us to restrict the processing of your personal data in the following circumstances:

- (a) you contest the accuracy of your personal data, for a period enabling us to verify the accuracy of the personal data;
- (b) the processing is unlawful and you oppose the erasure of the personal data and request the restriction of their use instead;
- (c) we no longer need the personal data for the purposes of the processing, but they are required by you for the establishment, exercise or defence of legal claims: or
- (d) you have objected to processing pending the verification whether the Association's legitimate grounds override those of yours.

Where processing has been restricted, such personal data shall, with the exception of storage, only be processed with your consent or for the establishment, exercise or defence of legal claims or for the protection of the rights of another natural or legal person or for reasons of important public interest.

### Right to object to processing

On the contact given above (office@amnesty.hu), you can ask us via e-mail you can object to the processing of your personal data that is done for the purposes of our or a third person's legitimate interests.

In such case we can no longer process your personal data unless we demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms or for the establishment, exercise or defence of legal claims.

On the contact given above (office@amnesty.hu), you can ask us via e-mail you can object to the processing of your data for direct marketing purposes, in which case your personal data may not be used any further for such purpose.

## Right to data portability

On the contact given above (office@amnesty.hu), you can ask us via e-mail you can ask us that we transfer the personal data concerning and provided by you in a structured, commonly used and machine-readable format, and you can transmit these personal data to another person controller without hindrance from us. You have these rights if the processing is based on consent or on a contract and the processing is carried out by automated means.

In exercising your right to data portability you can have the personal data transmitted directly from one controller to another, where technically feasible.

# Your legal possibilities concerning data processing

In case you experience unlawful data processing, before starting a legal procedure, please send your complaint first to us, so that we can restitute lawfulness.

By filing a complaint, saying that your rights have been violated or are directly being threatened, you may initiate an inspection at the supervisory authority. Name and contact details of the supervisory authority are as follows:
